Sign and Outdoor Advertising Section 3.05, Article D- Item 5 of the City of Saluda Zoning Ordinance permits the following:

1. A Temporary Sign attached to a window, door, wall, column, pole, post, fence, or railing may be allowed, provided it does not exceed in aggregate twenty-four (24) square feet of sign area. **One (1) interchangeable temporary sign** will be permitted for an individual, business, organization, or corporation for any combination of time from a 24-hour period, to a 365-day time period.
2. A Temporary sign permit may be issued for the applicant only if a Permanent Sign permit (if applicable) has been reviewed, approved and issued per the City of Saluda, NC Zoning Ordinance Section 3.05.
3. A Temporary sign must be maintained in a like new condition, properly attached and taut, for the permit to be compliant and valid within the Zoning Ordinance.
4. A Temporary sign shall not be used in lieu of permanent type sign(s) or signage (Ground Pole, Facade, Off-Premise, and Building) (Sec 12.03 Definitions) within all Zoning Districts.
5. Temporary signs shall be allowed for activities expressly permitted in the zoning district in which the applicant is located.
